## **Officers Reports**

### **Baron & Baroness**

Championship happened with only one B. We have a full suit of new champions and everyone who took part played fair. Thank you to the steward and his team. Thank you to Lady Leoflaeda for the children's activities.

We attended Highland Gathering, it was a great demo by Dragon's Bay. Thank you to everyone who came to help. It was well received.

#### Seneschal

Not had a lot of time over the last month for Seneschal jobs. Thankfully the Canton of Dragon's Bay seems more on an even keel with Lady Magdelana as new Seneschal and good support from the group.

#### Reeve

Opening Bank Balance 1 September 2022 - \$24,849.03 Closing Bank Balance 30 September 2022 - \$26,145.69

Income for the month mostly comprised payments for Championship which is why there was a reasonable increase in the bank balance over the month. This is despite \$1610 being paid to Ern Halliday as deposit for the site for Championship 2023. Other expenses for the month were the usual storage and site hire costs and a \$330 food float for Championship. The majority of championship expenses have been/will be paid in October (around \$2000) so next month will see a decline in the bank balance.
